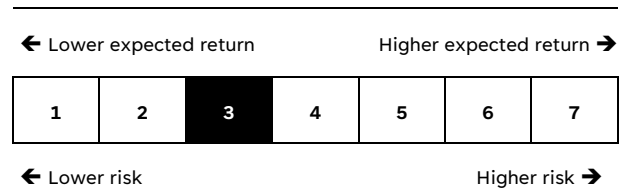

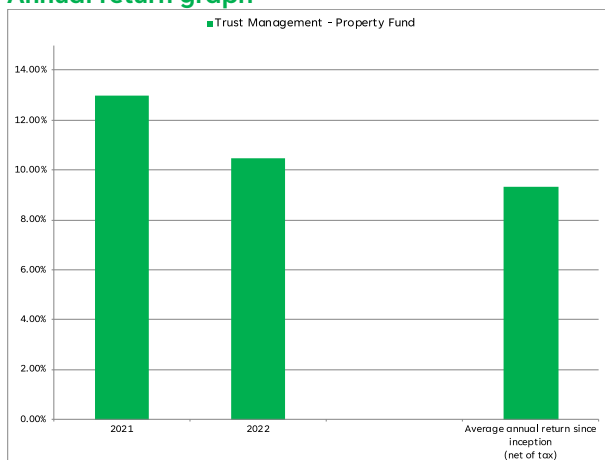

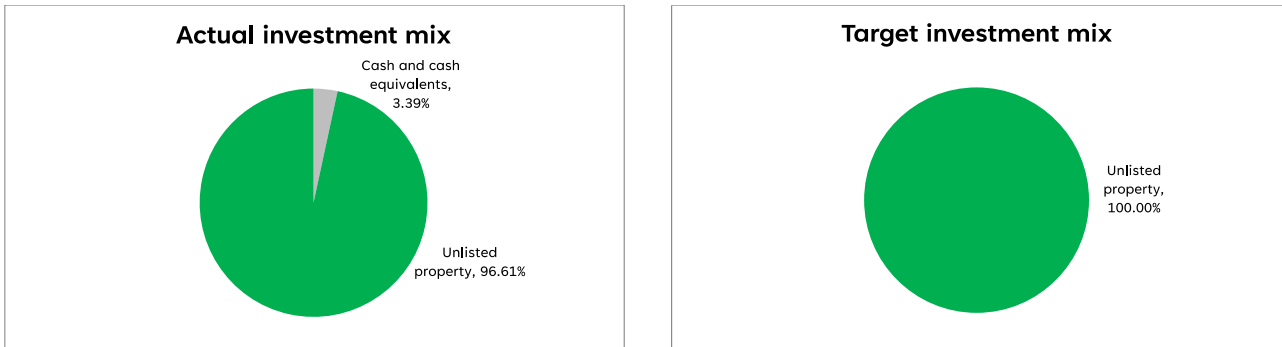

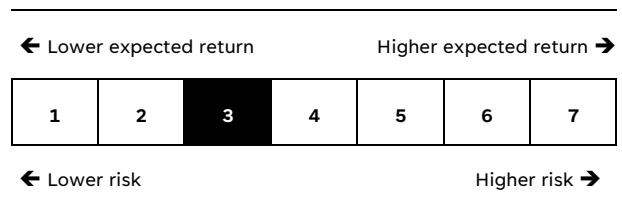

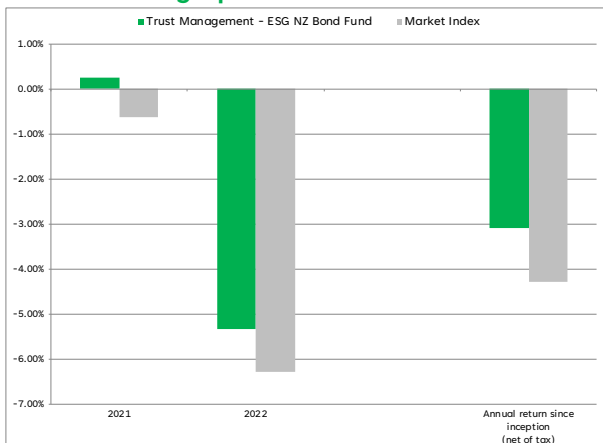

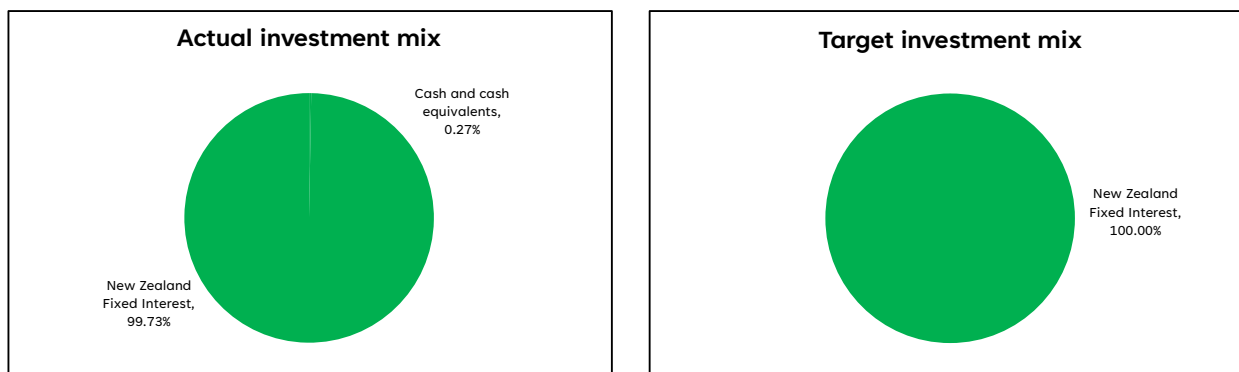

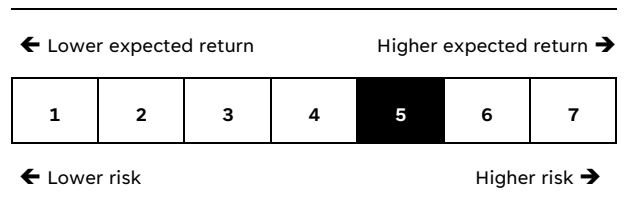

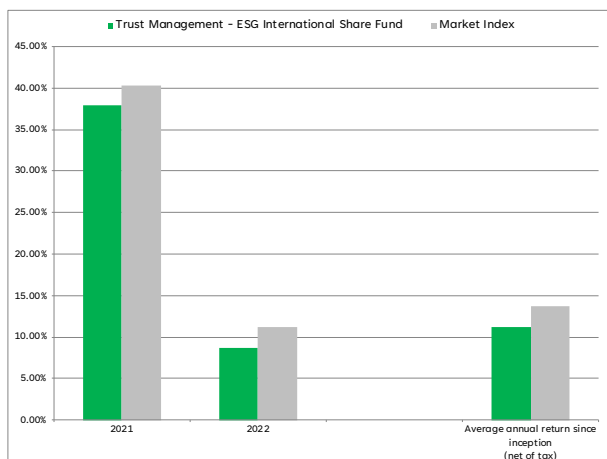

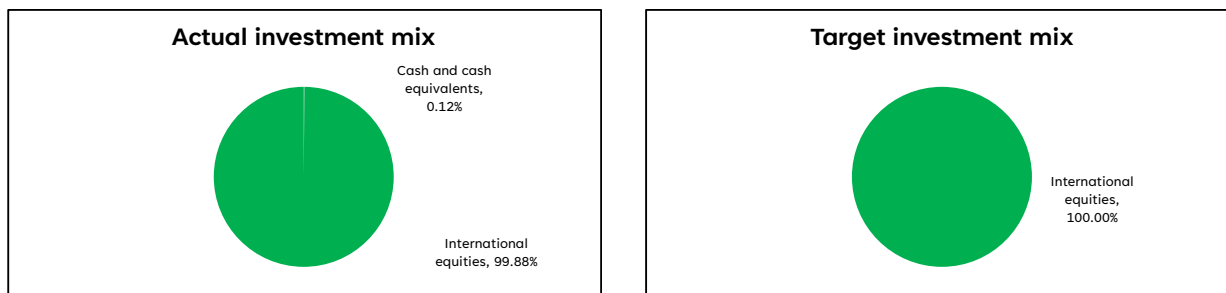

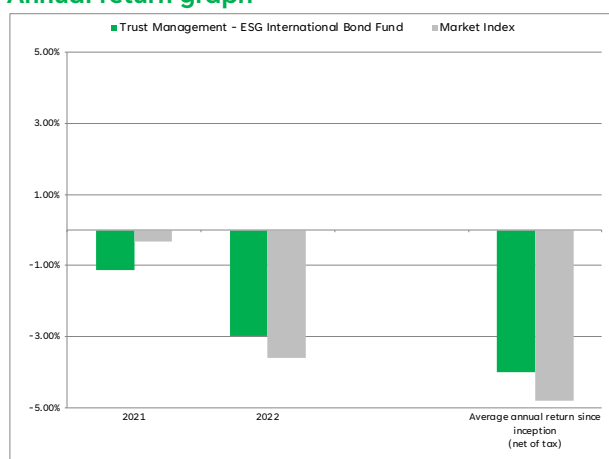

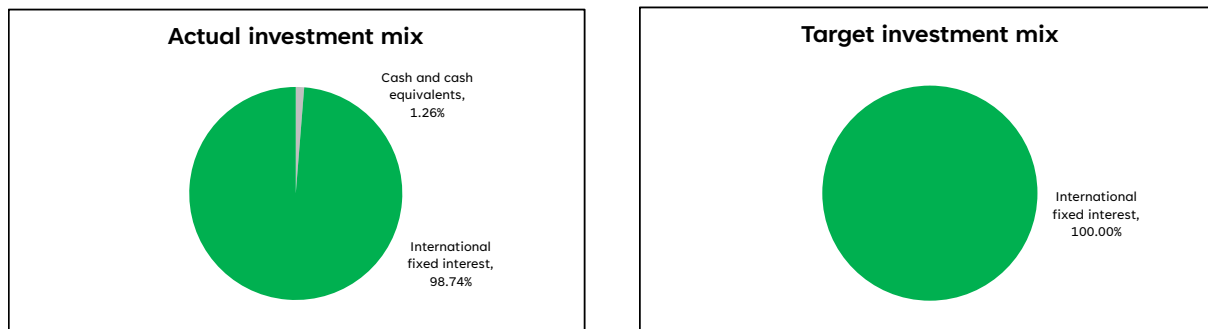

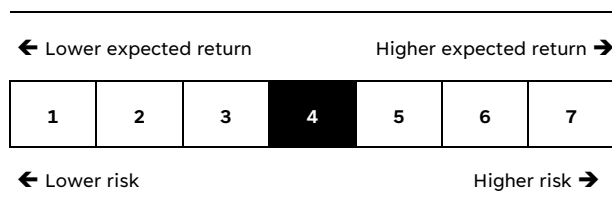

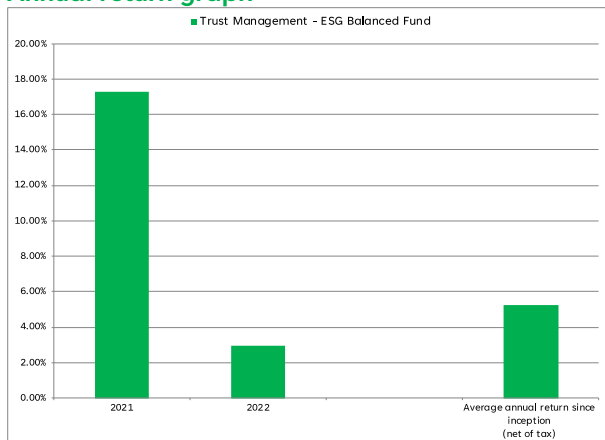

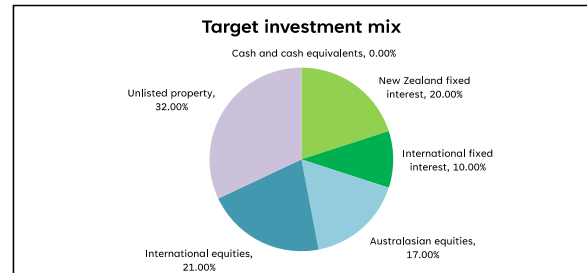
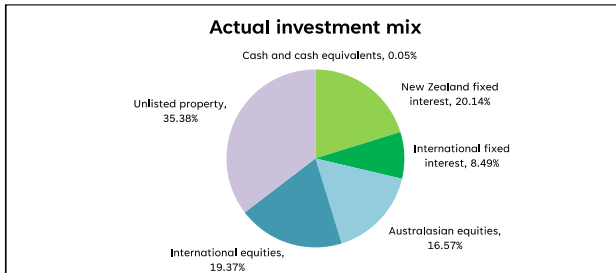
Example of how this applies to an investor

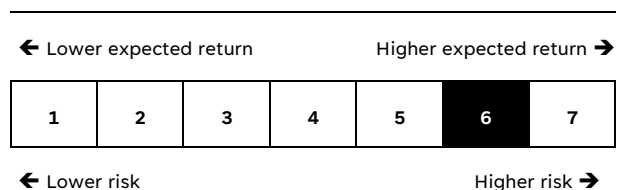

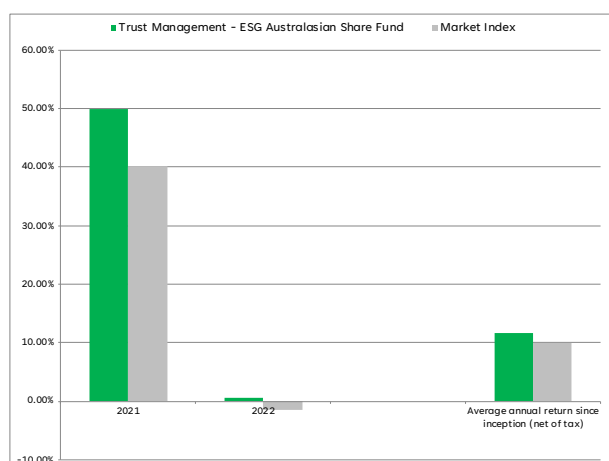

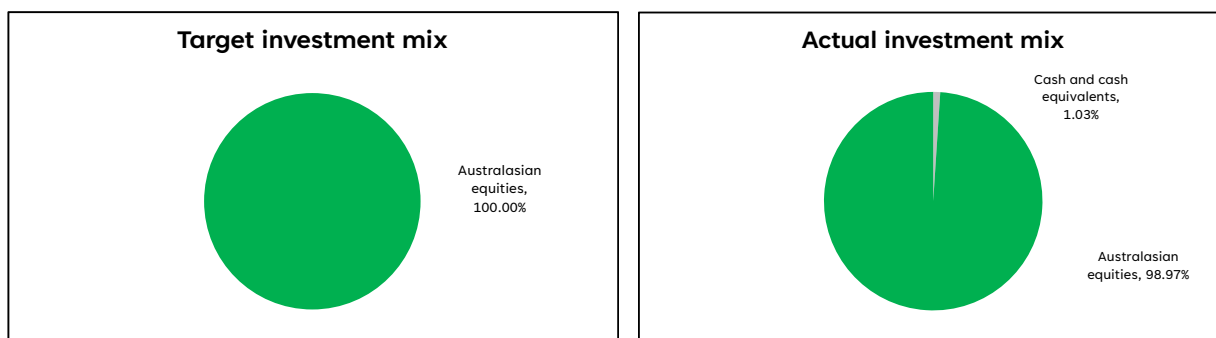
